#### Legal Basis of this Self-Declaration:

Our institution is obliged to comply with special access restrictions due to the legal regulations of the German Protection against Infection Act (IfSG) and the applicable hygiene regulations. In the event of a confirmed case of infection (SARS-CoV-2), we are instructed in accordance with § 36 IfSG for the protection of all persons to pass on the contact details of the persons to the public health department (among others in accordance with § 25 IfSG) on request and under a purpose-related requirement regarding the traceability of infection chains.

Therefore, please note that the provision of your personal data is based on your voluntary decision but is a legal requirement for entering our facility. We would therefore like to point out that you are not allowed to enter our facility without providing the required, factually correct contact data. A self-declaration completed by you is earmarked for a specific purpose (in accordance with Art. 9 of the Basic Data Protection Regulation (DSGVO)) and is protected against access by unauthorised persons. After storage for a maximum of 28 days, your data will be deleted again after fulfilment of the purpose (in accordance with Art. 17 Para. 1 DSGVO). Validity and exceptions of the obligation to report the fact no. 1 "stay abroad and personal contact" are described in part 6 of the applicable SARS-CoV-2 Containment Measures Ordinance - SARS-CoV-2-EindmaßnV in Berlin.
