

School Fees Regulations of the Klax School

The costs are flat-rate amounts that already take into account holiday periods and student absences due to illness.

Family income is not inquired about before signing a school contract and does not affect student admission.

School fees include:

- **At primary level:** breakfast, snack and all-day fruit/vegetables and drinks (tea/water), lunch is funded by the Senate
- **At secondary level:** breakfast, lunch, snack and all-day fruit/vegetables and drinks (tea/water), Club Line, use of Makerspace, creative materials, any necessary tuition

School fees **do not** include:

- Project trips, excursions, entrance fees, personal consumables, internal school events, workbooks

Textbooks are provided on loan to students.

Discounts for new contracts:

- Loyalty discount of 25% per child if the child has attended a Klax facility for at least one year and then seamlessly joins the Klax School.
- Discount for siblings if more than one child attends the Klax School (after deduction of any loyalty discount already granted):
 - o 1st sibling: 25 %
 - o 2nd sibling: 50 %
 - o 3rd sibling: 75 %

Exemption or reduction of school fees

Up to a gross annual income of €30,000.00 (income of both parents) or €15,000.00 (income of single parent), a reduction in school fees from the school authority can be applied for. The decision will be made by the school authority on a case-by-case basis. The food allowance included in the total price must always be paid. Applications can be made at any time and will be considered from the first of the month following the application. An exemption or reduction is only valid for one school year or, if the application is made after the start of the school year, until the end of the same school year. The application must be re-submitted for each school year. Only complete applications will be considered. To submit an application, please contact **kundenbetreuung@klax-online.de**.

After-school care

- After-school care or presentation of the after-school care voucher is compulsory in grades 1-4
- Fees are based on the official after-school care voucher, which must be submitted

As long as **no** after-school care voucher has been submitted, we charge €430.00 per month for the privately financed after-school care centre.

Fees:

- Admission fee: €375.00 per child, due upon enrolment
- Reminder fee: € 2.50 for each reminder

All prices are final, i.e. VAT is included.

The School Fees Regulations come into force on 01.04.2025 and apply to all school and after-school care contracts concluded on or after 01.08.2025.
