*Lunch is not included in the meal allowance for the primary school, as it is funded by the Berlin Senate Administration.

The above fees are flat-rates and already account for holiday periods and absences due to illness.

Household income is not requested prior to the conclusion of a school contract and is not a criterion for admission.

Included in the school fees

Primary Level:

Breakfast, afternoon snack, and all-day provision of fruit, vegetables, and beverages (tea/water). Lunch is funded by the Berlin Senate Administration.

Secondary Level:

Breakfast, lunch, afternoon snack, and all-day provision of fruit, vegetables and beverages (tea/water).

Additionally included:

Club activities, use of the Makerspace, creative materials, and additional support lessons if required.

Not included in the school fees

Educational trips and excursions, entrance fees, personal consumable materials, internal school events, and workbooks.

School textbooks are provided on a loan basis.

Other Fees

- Enrolment fee: € 375 per pupil (payable upon registration)
- Reminder fee: € 2.50 per payment reminder

Discounts for New Contracts

- Loyalty discount: 25% per child if the child has attended a Klax institution for at least one year and subsequently enrolls directly at Klax International School.
- Sibling discount (after deduction of any applicable loyalty discount):
 - 1st sibling: 25%
 - 2nd sibling: 50%
 - 3rd sibling: 75%

Exemptions and Fee Reductions

For a proven gross annual household income of up to € 29,429, the tuition fee is reduced to € 100 per month. In this case, the enrolment fee is waived.

In addition, the school provider allocates 10% of total tuition revenue for full or partial fee remission for pupils in financial need.

Applications for exemption or reduction may be submitted to the school provider at any time. Decisions are made on a case-by-case basis upon proof of financial need.

Approved reductions will take effect from the first day of the month following submission.

Fee exemption or reduction apply only for one school year or, if granted after the start of the school year, until the end of that school year. A new application must be submitted for each school year.

Only complete applications can be processed.

After-School Care (Hort)

- After-school care, or submission of an official after-school care voucher, is mandatory for Years 1–4.
- Fees are determined based on the official after-school care voucher and must be submitted accordingly.

If no voucher is submitted, privately funded after-school care will be charged at € 430 per month.

This Schedule of School Fees comes into effect on 1 April 2026.

All prices are final prices; any applicable VAT is included.
